

Minutes of Mikado Township Board Meeting
December 12, 2022

Supervisor Corn arrived: Meeting called to order.

Roll Call showed Supervisor Corn, Treasurer Travis, Clerk Sutton, Trustee Mullins, Trustee Nedo were present

Approval/Adjustments to the Agenda: Sutton moved, Mullins seconded to approve agenda as presented.

The Financial Report for **November 2022** was given by Treasurer Travis as follows: The General Fund balance brought forward was **\$213,865.69**, with receipts of **\$17,444.14**, less disbursements of **\$14,333.82** leaves a balance in the General Fund of **\$216,976.01** plus CD's of **\$20,000.00** (\$10,000.00 being Stabilization CD) leaves an overall balance in the General Fund of **\$236,976.01**. The Road MIF balance brought forward was **\$35,420.87**, with receipts of **\$9.13**, less disbursements of **\$0.00**, leaves a balance in the Road MIF of **\$35,430.00** plus CD's of **\$20,000.00** leaves an overall balance in the Road MIF of **\$55,430.00**. The Fire MIF balance brought forward was **\$56,134.15**, with receipts of **\$9.54**, leaves a balance in the Fire MIF of **\$56,143.69**, with disbursements of **\$0.00**, leaves a balance of **\$56,143.69**, plus a CD in the amount of **\$10,000.00**, leaving an overall balance in the Fire Fund of **\$66,143.69**.
